K. Concluding declaration

1. I declare that I have submitted all information on section B-J to the best of my knowledge and belief and this information is complete with all documents that are available to me. Documents in languages other than German are submitted in a German translation. If required to do so, I shall also present the originals of the documents which have been enclosed as photocopies.

2. I acknowledge that I will submit in writing any change to my statements before I enter Austria to the respective Austrian embassy or consulate and after my entry into Austria directly to the responsible authority in Austria. I also will enclose all necessary documents.

3. I understand that the applicant must collect the residence permit him-/herself (except where there is a statutory representative).

4. I acknowledge that any incomplete or incorrect statement as well as non-compliance with K 2 and K3 (as stated above) can result in the rejection of the application or the permit's extension.

5. I acknowledge that a further application for a residency permit in Austria can only be accepted if the application is made for the same purpose as the original permit and only if all legal conditions (as set forth in the Austrian Alien Act and the Alien Employment Act) apply.

6. I acknowledge that applying for an extension of a category A1 permit in Austria is possible only if either appropriate proof (as issued by school/college) is presented or the necessary requirements for being a “key worker“ are fulfilled.

7. I understand that if I file for an extension before my permit’s expiration date in Austria, I can legally stay in Austria till a final decision has been made.
