



**COMMUTER DINING FUNDS CONTRACT  
 2009-2010 ACADEMIC YEAR**

Commuter Dining Funds allows students to take advantage of the computerized declining balance program and allows students the flexibility of charging these amounts to the student account. Dining Funds can be used in all Black Bear Dining Facilities, including Hilltop, Wells Central, Wells Market, York, the Maine Marketplace, Oakes Room Café, as well as the Campus Convenience Markets, Bear’s Den, Union Central, and Bear Bites Too - plus you save 5% over cash prices.

Dining Funds can be purchased for any amount above the minimum of \$25.00. Dining Funds cannot be charged to a student account with an account balance of \$100.00 or more. **COMMUTER DINING FUNDS CONTRACT TERMS AND CONDITIONS — Effective Fall 2009**

1. Commuter Dining Funds are good through May 9, 2010. Any unused Dining Funds are forfeited after May 9, 2010.
2. Commuter Dining Funds may be purchased for the 2009-2010 academic year between July 1, 2009 and April 16, 2010.
3. Commuter Dining Funds may not be sold and charged to a student’s account between April 17, 2010 and May 10, 2010.
4. Students may purchase additional Commuter Dining Funds if paying by cash, check, credit or debit card.
5. Commuter Dining Funds can be used to purchase guest meals and groceries.
6. A lost, stolen or damaged MaineCard must be reported to the Student Service Center, 143 Memorial Union or the [Online MaineCard Office](#). A replacement charge of \$15.00 will be assessed to the student account.
7. The purchasers of the Commuter Dining Funds agree to comply with the rules and regulations of the University of Maine and Black Bear Dining. The University is entitled to terminate this agreement if the purchaser is found to be in violation.
8. Commuter Dining Fund balances will be refunded ONLY if the student withdraws from the University before the end of the meal plan year. Requests for refunds must be made in writing to the Director of Dining Operations, 101 Hilltop. Refunds will not be made for unused Commuter Dining Funds after May 9, 2010.
9. If application is sent by mail, please allow two (2) business days for processing after receipt by MaineCard Services. Check with any Black Bear Dining cashier for status of account activation.
