

**COMMUTER MEAL PLAN CONTRACT
2011-2012 ACADEMIC YEAR**

The Commuter Meal Plan allows students to take advantage of a computerized declining balance program for dining funds or meal plan.

Commuters have several options of meal plans/dining funds per semester. All meal plans are accepted at Hilltop, York, and Wells Central all-you-care-to-eat facilities. Dining funds can be used in all dining facilities - Hilltop, Wells Central, York, Maine Marketplace, Oakes Room Café, as well as the campus convenience markets, Bear's Den, Union Central, Bear Bites Too! and athletic concessions.

Additional dining funds may be purchased in any amount above the minimum of \$25. Commuter dining funds may be purchased for the 2011-2012 academic year between July 1, 2011 and April 14, 2012. Dining funds cannot be sold and charged to a student account between April 14, 2012 and May 5, 2012. Dining funds cannot be charged to a student account with a balance of \$100 or more. COMMUTER MEAL PLAN CONTRACT TERMS AND CONDITIONS — Effective Fall 2011

1. The Commuter Meal Plan for the 2011-2012 academic year is available until May 5, 2012. Any unused dining funds are forfeited after May 5, 2012.
2. This contract is valid for each academic semester. Students need to reapply for consecutive semesters.
3. Students signing up for a Commuter Meal Plan after the beginning of the academic semester may opt for either 1) the full value of the semester rate or 2) a lesser value which is pro-rated according to date of application.
4. A lost, stolen, or damaged MaineCard must be reported to the MaineCard Service Center, 130 Memorial Union. A replacement charge of \$15 will be assessed to your student account.
5. The purchaser of the Commuter Meal Plan agrees to comply with the rules and regulations of the University of Maine and Black Bear Dining. The University is entitled to terminate this agreement if the purchaser is found to be in violation.
6. Commuter Meal Plans will be refunded ONLY if the student withdraws from the University before the end of the meal plan year. Requests for refunds must be made in writing to the Director of Dining Operations, 101 Hilltop. Refunds will be pro-rated per diem or meals used or whichever one is greater. Refunds will not be made for unused Dining Funds after May 5, 2012.
7. If application is sent by mail, please allow two business days for processing after receipt by MaineCard Services. Check with any Black Bear Dining cashier for status of account activation.
