

Certification of Finances – Instructions

ALL INTERNATIONAL STUDENTS MUST FILL OUT THE REVERSE SIDE OF THIS FORM

All international students are required by U.S. immigration law to show proof that they have the financial ability to attend an educational institution in the United States. The University of Maine requires that you present evidence of financial support for at least one academic year.

If you will be self-supported: You can choose either Option A **OR** Option B to prove finances.

Option A: Please send an original bank letter or statement (or notarized copy) that clearly states the balance available in your personal bank account. This statement or letter must clearly state the currency, be less than one year old, and be in English.

OR

Option B: Have the “Certification from the Bank” form completed, signed, and certified by a Bank Official stating the current balance and currency of your bank account.

If you will have a sponsor: You must choose Option A **OR** Option B **OR** Option C to prove finances.

Option A: Your sponsor must complete the “Affidavit of Support Form” **AND** please send an original bank letter or statement (or notarized copy) that clearly states the balance available in your sponsor’s personal bank account. This statement or letter must clearly state the currency, be less than one year old, and be in English.

OR

Option B: Your sponsor must complete the “Affidavit of Support Form” **AND** have the “Certification from the Bank” form completed, signed, and certified by a Bank Official stating the current balance and currency of your sponsor’s bank account.

OR

Option C: Your sponsor’s bank can write an original letter on Bank Letterhead in English indicating the sponsor’s available funds and that the sponsor is willing to support the student. This letter from a Bank Official would replace the need for both the “Affidavit of Support” and the “Certification from the Bank” forms.

PLEASE NOTE: All forms must be originals (or official notarized copies) and must be submitted in order to be considered for admission to the University of Maine Graduate School.
