INTERNATIONAL STUDENT APPLICATION CHECKLIST

The University of Maine welcomes students from all over the world. Approximately 500 students from over 70 countries are studying at the University.

The following is a list of important steps in applying for admission to the University of Maine. *Please keep this checklist for your records.* When it is complete, you will have sent the necessary forms and documents to the University of Maine to apply for admission. Remember the documents should reach us before the following deadlines: **November 1** for admission in January and **April 1** for admission in September.

- 1. Read the prospective international student information sent with application to learn about the University of Maine.
- 2. Select a major program of study offered at the University of Maine and select an alternative major.
- 3. Read and complete the International Student Application. Please list all prior educational experience, all tests taken and all certificates or diplomas earned. List your areas of academic interests.
- 4. Read and complete the Certification of Finances form.
- 5. If you have taken the Scholastic Aptitude Test (SAT), have results sent directly to the University of Maine Office of International Programs (UMaine code: 3916).
- 6. Request that your test of English as a Foreign Language (TOEFL) scores be sent directly to the Office of International Programs, if English is not your first language or official national language.
- 7. Have official educational records, **along with certified English translations (if necessary)**, sent directly to the Office of International Programs.
- 8. Obtain financial documentation (official bank letters, other documents, sponsor letters, employer letters, notarized parental statements) to demonstrate your ability to finance your education at the University of Maine.

IMMUNIZATION LAW

—The State of Maine requires all students born after 1956 to furnish proof of immunization against measles, rubella, tetanus, and diphtheria. Proof of immunization must be on file at Cutler Health Center prior to finalization of registration. International applicants should forward proof of immunization as soon as possible after notification of admission to: Cutler Health Center, University of Maine, Orono, ME 04469 USA.

—All students and dependents are required to have University of Maine Health Insurance or equivalent provided by sponsoring agency.

HOUSING INFORMATION FOR STUDENTS AND FAMILIES

All single international students who request on-campus housing and who are new to the U.S. are guaranteed on-campus housing. All single first-year undergraduates are required to live on campus. *It is strongly recommended that all international students not accompanied by family live on campus for at least the first year.*

For those students who have brought dependents, which include children, wife or husband, the University operates University Park. University Park has available one, two, and three bedroom apartments within walking distance of the main campus. If you are not able to obtain an apartment at University Park, you must find other off-campus housing for your family. The International Office will direct you to several resources.

THE INTENSIVE ENGLISH INSTITUTE

Established in 1987, the Intensive English Institute (IEI) of the University of Maine is a department in the College of Liberal Arts and Sciences. The primary goal of the IEI is to prepare international students for university study at UMaine and other American universities and colleges. The IEI accepts students with non-degree, conditional admission or matriculated graduate and undergraduate student status. In addition to a full-time course of study, the IEI offers academic advising, cross-cultural counseling, tutorials and self-study opportunities in a variety of content and skill areas.
